Social Distancing for COVID-19

- Social distancing measures are taken to restrict when and where people can gather to stop or slow the spread of infectious diseases. Social distancing measures include limiting large groups of people coming together, closing buildings and canceling events.
- It is important to stay 6 feet away from others.

Protect yourself and your community. Wash your hands often with soap and water for at least 20 seconds, especially after going to the bathroom, before eating, and after blowing your nose, coughing or sneezing. If you don't have soap and water, use an alcohol-based hand sanitizer with at least 60% alcohol. Avoid close contact with people who are sick, and stay home when you're sick. 	Change your daily habits. Avoid shopping at peak hours and take advantage of delivery or pick-up services with retailers.  Work with your employer. Cooperate with leadership to change company practices, set up flexible shift plans, have employees telecommute, and cancel any large meetings or conferences. 
Look for communications from universities and colleges: Regarding suspending classes, going to web-based learning and canceling all large campus meetings and gatherings. 	Keep at least six feet between you and other people. Avoid shaking hands as a social greeting.

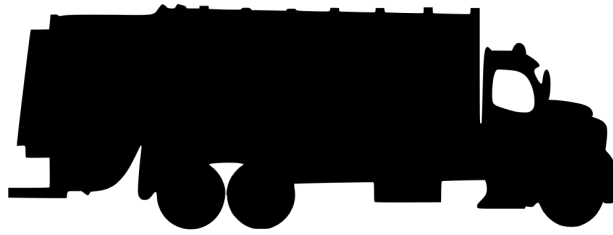

Go Green SAB

The City of St. Augustine Beach is going green! Single-use plastics have long lifespans, impacting local habitats and natural areas, and are not easily recyclable. Eliminating the use of these products decreases litter on our streets and reduces plastics in the environment (especially the ocean).

Starting January 1, 2020, the City is launching a “Go Green SAB” campaign, which encourages businesses in the limits of St. Augustine Beach to voluntarily eliminate the use of these products. To recognize the efforts of businesses who have done so, the City will issue a “Go Green SAB” window cling, as well as mention their efforts on social media and in the City’s monthly e-newsletter.

“It is our goal to get every business in the City limits involved in this campaign,” said St. Augustine Beach Mayor Undine George. “We are excited to be a leader in environmental protection and hope other Cities will follow our example.”

If a business wishes to participate, they can visit the City Manager’s Office (2200 A1A South, St. Augustine Beach, FL 32080) to pick up a window cling starting January 2, 2020. Since this is a voluntary campaign, the City is relying on the word of business owners and managers and will not be conducting inspections or penalizing organizations who do not wish to participate.

New Emergency Notification System for St. Johns County Residents

St. Johns County is launching a new emergency notification system to

provide residents with critical information during emergency situations. Beginning February 1, the new Alert St. Johns system will enable St. Johns County, the St. Johns County Sheriff's Office, the City of St. Augustine, and the City of St. Augustine Beach to quickly provide residents with critical information in a variety of situations including severe weather, unexpected road closures, water advisories, missing persons, evacuations of buildings or neighborhoods, and incidents that may threaten public safety.

To receive these time sensitive alerts, residents can sign up at <https://member.everbridge.net/index/892807736725582#/login>. Those who sign up can choose to receive notifications via a phone call to their home, business, or mobile phone, by email, or text message. The Alert St. Johns system will replace the Code Red notification system, so it is imperative that residents sign up for these critical notifications.
