Go Green SAB

The City of St. Augustine Beach is going green! Single-use plastics have long lifespans, impacting local habitats and natural areas, and are not easily recyclable. Eliminating the use of these products decreases litter on our streets and reduces plastics in the environment

(especially the ocean).

Starting January 1, 2020, the City is launching a “Go Green SAB” campaign, which encourages businesses in the limits of St. Augustine Beach to voluntarily eliminate the use of these products. To recognize the efforts of businesses who have done so, the City will issue a “Go Green SAB” window cling, as well as mention their efforts on social media and in the City’s monthly e-newsletter.

“It is our goal to get every business in the City limits involved in this campaign,” said St. Augustine Beach Commissioner Undine George. “We are excited to be a leader in environmental protection and hope other Cities will follow our example.”

The **Spanish treasure fleet**, or **West Indies Fleet** from Spanish *Flota de Indias*, also called silver fleet or plate fleet (from the Spanish *plata* meaning "silver"), was a convoy system of sea routes organized by the Spanish Empire from 1566 to 1790, which linked Spain with its territories in the Americas across the Atlantic. The convoys were general purpose cargo fleets used for transporting a wide variety of items, including agricultural goods, lumber, various metal resources such as silver and gold, gems, pearls, spices, sugar, tobacco, silk, and other exotic goods from the overseas territories of the Spanish Empire to the Spanish mainland. Spanish goods such as oil, wine, textiles, books and tools were transported in the opposite direction.^{[1][2]} The West Indies fleet was the first permanent transatlantic trade route in history. Similarly, the Manila galleons were the first permanent trade route across the Pacific. From Wikipedia

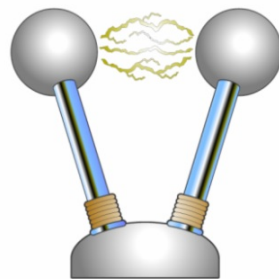
