## **April 4<sup>th</sup>, 2023**

The City of St. Augustine Beach has contracted with D.B.Civil Construction Company to add new curb and gutter as well as milling and resurfacing the 100 block of 2<sup>nd</sup> Street, west of A1A Beach Boulevard. The Contractor is currently scheduled to perform this work starting April 10<sup>th</sup>, 2023. Owners/residents can expect to have **LIMITED ACCESS TO THEIR DRIVEWAYS** during construction. The estimated time for construction to be completed is the end of Summer 2023.

Owners/residents will receive two (2) parking passes per residence. Parking passes will be delivered to each resident late this week or early next week. If additional parking passes are needed the residents/owners are requested to contact the Public Works Department. The parking passes will enable owners/residents the ability to park overnight on 2<sup>nd</sup> Avenue located off of 1<sup>st</sup> Street, as well as any City owned parking lots.
